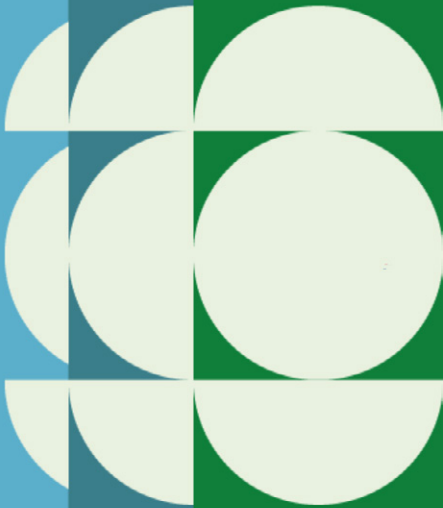

Since its establishment in 1988, **Aida-Commerce d.o.o.** has continuously expanded and diversified its range of products and services. Today, it stands as a leading company in the fields of recycling, hazardous and non-hazardous waste disposal, separator cleaning, and communal services. We specialize in the collection, processing, and recycling of hazardous and non-hazardous waste, proudly collaborating with numerous government institutions and private companies. A significant portion of our clients are export-oriented companies that operate under strict EU environmental regulations, aligned with green economy policies.

Our process begins at the waste producers' locations, where we collect waste using ADR-certified vehicles. All transport is carried out by ADR-trained drivers to ensure full compliance with safety and legal standards. Upon arrival at our recycling facility, the waste is weighed and classified according to the UN waste classification system and the European List of Waste. The sorted waste is then stored in covered areas until it is transferred to specialized processing plants, depending on its type.



After treatment, any residual waste is exported to EU countries through our network of licensed exporting partners, with whom Aida-Commerce d.o.o. maintains long-term contracts.

Headquartered in Sarajevo, Aida-Commerce d.o.o. has a long-standing tradition in the purchase and recycling of secondary raw materials, including scrap iron, aluminum, copper, batteries, and more. Since 2013, we have expanded our services to include the recycling of PET packaging, plastic, paper, nylon, and cardboard, as well as the treatment of wastewater and oily liquids. In 2015, we further broadened our operations to include the disposal of hazardous, non-hazardous, and medical waste.

Additionally, we have established specialized departments for:

- CCTV inspection and rehabilitation of wastewater pipelines (water supply, sewage, etc.)

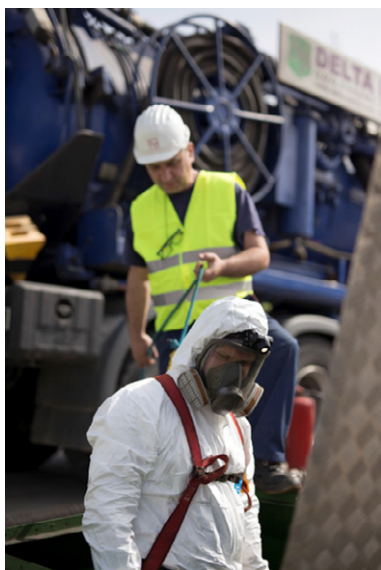
We are the largest and most equipped company in Bosnia and Herzegovina for hazardous and special waste treatment and recycling, and for various industrial cleaning jobs.

EKO SIR PUĐA

Company "EKO SIR PUĐA" was established in 2001, continuing family tradition in cheese production from milk of animals grazing mountain grass. Company headquarter is located in region of Bosnia and Herzegovina which is traditionally oriented on animal husbandry and cheese production, in the village Golinjevo, near main road Livno-Mostar, on the side slope of Mountain Tušnica at close vicinity of Buško Blato lake. Expanding EU market pushed firm to open new establishment in 2013, on the location in Čaprice, near Trilj in Republic of Croatia, where we joined traditional recipes with most modern technology in order to process locally collected milk in excellent high quality cheese. Further market demand led us in 2014 to the acquisition of cheese factory "Sabalić" located on island Pag (Croatia), where we seasonally produce exclusively traditional cheese from Pag.

Our core product is Livanjski cheese, but we also produce other traditional hard cheeses of recognizable quality, prepared from full-fat cow's, sheep, and goat milk, as well as a variety of other semi-hard and soft cheeses.

Livanjski cheese

The place of origin of Livanjski cheese is area of southwestern Bosnia, the wide area of the Livanjsko field, from where its production spread to the area of Glamoč and Tomislavgrad.

Production of Livanjski cheese began during the time of the Austro-Hungarian monarchy in 1886,

when representatives of the monarchy saw that there were ideal conditions for cheese production in this area. With establishment of the Zemaljska agricultural station, which also included first cheese factory, they began an organized approach to animal husbandry and cheese production. Representatives of authorities organized arrival of several master cheesemakers, among whom a Frenchman Cyprian Jaillet stood out. He spent a quarter of a century in Livno, and during his stay he significantly improved production of Livanjski cheese and became a prominent citizen of Livno.

Livanjac

A "younger brother" of Livanjski cheese, Livanjac cheese was created as an original product of Puđa family. It is result of many years of cheese production in the family, a home craft, when mothers cooked cheese by the stove, without special aids and machines, relying only on their own senses and experience. Livanjac is a hard cheese, produced from whole milk. Like Livanjski cheese, it ripens under a natural rind, and original family recipe gives it a special taste, smell and texture. Due to its milder aroma than Livanjski cheese, it is ideal for those who like less spicy food. Family cheese - for the whole family.

Trappist

Monastic simplicity and discipline translated into cheese is idea behind Trappist production. Trappist is produced as hard cheese whose production history in Bosnia and Herzegovina begins in the 19th century. Recipe created in the Eko sir Puđa dairy was modeled on secret, monastery recipes, passed down only by word of mouth from master to student. Trappist produced in Eko sir Puđa dairy is produced from non-skimmed milk. It ripens under a layer of protective coating, which allows



Trappist to keep its fine texture elastic and soft. It is characterized by a mild and pleasant smell and taste, which will win you over, regardless of whether you are a big cheese lover or not. It is cheese that goes equally well with meat dishes, and as a sandwich layer for a quick break at work. Simply perfect.

Sheep's cheese

Vast pastures of this part of Bosnia and Herzegovina, full of medicinal and aromatic plants, have been feeding Pramenka breed of sheep for centuries, small, woolen factories of the highest quality milk. Sheep's cheese produced in the Eko sir Puđa dairy is a real mine of minerals, vitamins and amino acids, with an intense smell and a spicy taste. Cheese that takes you back in time.



Goat's cheese

A bit neglected compared to other types of cheese. Goat's cheese from the Eko sir Puđa dairy is characterized by a specific smell and taste. Delicious ivory-colored slices also hide numerous beneficial properties. We produce cheese in large and small wheels, under an attractive black coating.



Sveti Roko

Sveti Roko is a cheese made with a unique family recipe, we produce it during the sheep milking season from a mixture of cow's and sheep's milk from mountain pastures.

Delminium

The name Delminium comes from the Latin name of the city Tomislavgrad, which in turn has its roots in the word Delma - the name for a sheep in the time of the ancient Illyrians. 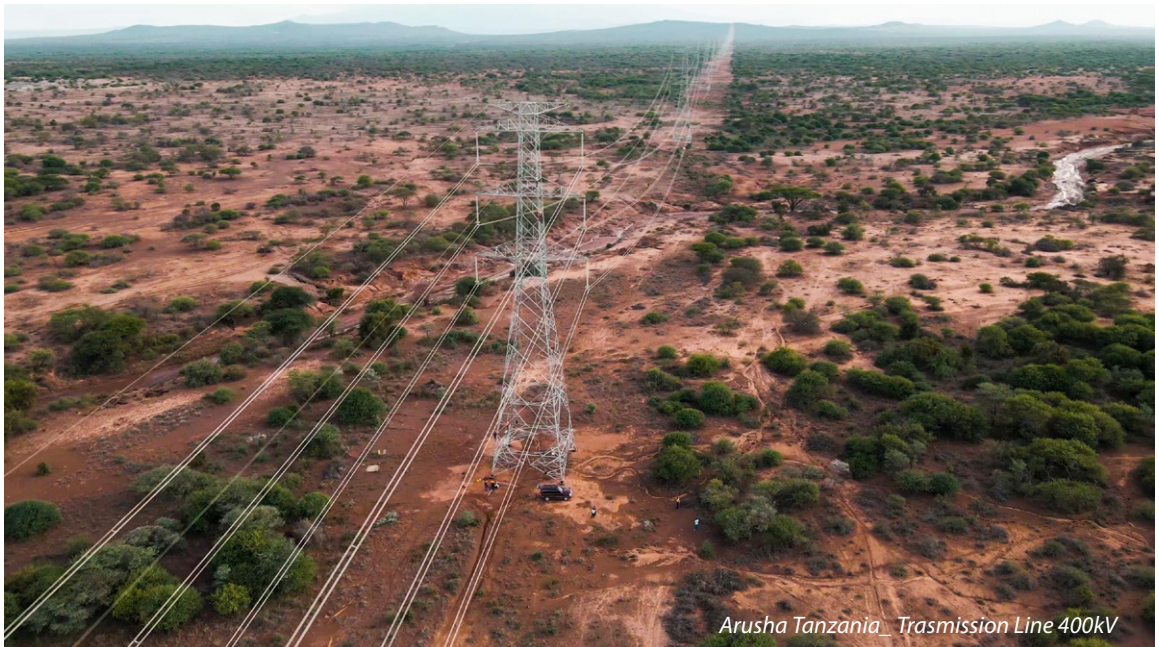

PD "Galvanorm" d.o.o. Konjic was established in 2020, primarily with the purpose of operating in hazardous waste and wastewater treatment activities. The guiding idea for this challenging activity, supported by significant initial investments, was realized in a very short time. The company's headquarters are located in the town of Konjic, one of the leading cities in Bosnia and Herzegovina in the field of industrial production. All infrastructure is situated in the Donje Polje Industrial Zone and consists of approximately 2,500 m² of production and storage facilities, with planned surfaces and road communications.

Since the activity itself involves the collection, temporary storage, treatment, and disposal of hazardous waste, the vehicle fleet is very important in this field of operation. We possess a specialized vehicle equipped for suction of contaminated and polluted water, with a capacity of 14,000 m³. In addition, our fleet includes multiple trucks intended for waste transport and collection, as well as a larger number of trailers and auxiliary machines required for smooth operational activities.



We have a complete wastewater treatment line, designed with environmentally friendly principles, producing treated and purified water as its final “product.” The use of such treated and purified water is versatile. The disposal of the final material resulting from hazardous waste treatment is in accordance with legal regulations and is exported to European Union countries.

Within our existing capacities, we have a fully equipped laboratory for monitoring and controlling wastewater parameters, as well as performing additional analyses as required by the processes. This ensures continuous quality control of the treated water and compliance with legal regulations. Upon request, we can provide reference reports on conducted analyses to our partners.

Considering that our operations involve activities that may result in pollution, an important segment of our work is providing maintenance services for external and internal oil-contaminated and polluted surfaces. We are proud that our services of this type have an increasing number of satisfied clients, which can be confirmed by our reference list. These works are performed using a high-pressure machine from the German manufacturer FALCH.

We are exclusive representatives of NALCO Ecolab, a leading global company in process

management and solutions. By providing NALCO Ecolab products, we promote environmental awareness, helping business entities operate in accordance with EU regulations.

ZEOS EKO-SISTEM

Who we are

Company ZEOS eco-system d.o.o. (hereinafter: System Operator) is the first operator of the Electrical and Electronic Equipment Waste Management System in Bosnia and Herzegovina, authorized by the Federal Ministry of Environment and Tourism. The System Operator is a legal entity, to which importers, distributors and manufacturers (System Participants) have delegated the obligation to report, manage and dispose of waste electrical and electronic equipment.

The legal framework under which the ZEOS eco-system operates is the Law on Waste Management and the Rulebook on Management of Waste Electrical and Electronic Equipment.

The purpose of the establishment of the System Operator is:

- to ensure that all participants of the system have equal and favorable business conditions,
- to avoid paying penalty fees prescribed by the Rulebook and to pay lower fees defined by the System Operator

- to facilitate the reporting by the participant of the system for sale or placement of new electrical and electronic equipment,
 - to establish a quality and sustainable system of disposal (processing and recycling) of electrical and electronic waste,
 - to provide legal support and free consultations for current and future System Participants.

The System Operator has been established as a service that is available to its System Participants, to use its knowledge and resources to best facilitate their reporting and fulfillment of their legal obligations. Also, the role of the System Operator is to ensure payment of fees for the placed electrical and electronic equipment which are lower than what importers, manufacturers and distributors would have paid had they done it on their own, which for the participants of the system means the reduction of operating costs. Also, the System Operator takes care of the disposal of electrical and electronic waste by the System Participants.

Besides providing services to System Participants (legal entities), ZEOS eco-system d.o.o. also provides possibility for citizens to dispose of their e-waste in the relevant street waste containers or bring it to the nearest recycling yard for free.
